## ESSENTIAL DUTIES AND RESPONSIBILITIES

The following duties and responsibilities are required. Additional duties may be assigned based on utilization and performance.

- Provides lifeguard services. Responds to emergencies and, if necessary, administers CPR/First Aid.
- Enforce all MPHOA aquatic facility policies, rules and regulations
- Complete records and reports as needed

- Participate in in-service training sessions and other staff meetings
- Complete additional duties as assigned by supervisors
- Daily cleaning and sanitization of equipment and program supplies when needed

### KNOWLEDGE AND SKILLS

- Have or obtain a thorough understanding of facilities emergency action plan
- Demonstrates an understanding of facility characteristics, rules, policies and procedures (training provided)
- Leadership and public relations skills
- Decision-making skills

- Checking chemicals in all bodies of water. (Training provided)
- Minimum 15 years of age

### PHYSICAL DEMANDS

The physical demands described here are representative of those that must be met by an employee to successfully perform the essential duties and responsibilities of this position. While performing the duties of this job, the employee is regularly required to speak and hear. Bodily movements include ability to sit; swim; use hands to finger, handle, and lift arms above shoulder level. The employee is required to stand; walk and reach with hands and arms, balance, stoop, and bend.

The employee must occasionally lift up to 50 pounds. Specific vision abilities required by this job include close vision, distance vision, peripheral vision, depth perception, and the ability to adjust focus.

### **WORK ENVIRONMENT**

The work environment characteristics described here are representative of those an employee encounters while performing the essential duties and responsibilities of this position. The functions of this position are performed in an indoor facility and the employee will be exposed to chlorine, pool chemicals, and lighting. While performing the duties of this job, the employee is exposed to chemically treated water for a minimum of 1 hour per day. The noise level in the work environment is usually moderate.
